

## CERTIFICATE of PRODUCTION

in accordance to the original Dr. Schuessler's methods

Dr. W. H. Schuessler started the biochemical treatment of tissue salts in 1873. Subsequently he moved to the United States of America where he practiced medicine and began producing these remedies.

His work was translated into English by Dr. W. Carey MD in 1894. The complete work of Dr. Schuessler was afterwards completed and published later by Dr. J. B. Chapman who had a more thorough knowledge of biochemistry. The Luyties Pharmaceutical Company of St. Louis, which held the production and marketing rights of Schuessler tissue salts in the traditional dosage form of soluble tablets, also published a book on the subject which helped to further popularise the science of these Salts.

In 1918 Leonard Stocks bought the rights for the commercialization of the Schussler tissue salts and for the publication of the book by Chapman on Biochemistry in the UK. Leonard Stocks bought also the rights to the design and use of machines to produce faithfully the original Schuessler's tablets. During World War II the Salt production was moved to England, in London, with the brand New Era Laboratories. At the same time, new laboratories were able to obtain permission to produce in the UK the range of twelve individual and eighteen complex tissue salts. The production of these medicinal substances took place in compliance with the current regulations governing the production of drugs (GMP). The company subsequently moved from Slough to Acton under the same ownership and management.

In 1973 it was sold to the pharmaceutical division of Guinness Peat. In 1987 it became the property of the Seven Seas and moved its production unit to Hull, producing, with authentic equipment, the same formulations faithful to the original. A dozen years later Seven Seas Ltd was acquired by Merck Group, one of the oldest chemical-pharmaceutical companies still operating, which in 2012 sold the branch of the New Era Laboratories to OLIMED Limited based in London. OLIMED Limited, a subsidiary of NAMED S.p.A. has transferred the production unit of the Schuessler Tissue Salts to Italy, patenting and maintaining the authenticity of the production of the Salts with the most technologically advanced machinery.

The above shows the authenticity and compliance with the original production methods of New Era® Tissue Salts. The production of these salts is carried out in accordance with the rules laid down by the Italian and English Ministry of Health which have granted registration.

Currently the New Era® products are being marketed in several countries in the world. We certify that the current New Era® tissue Salts are the only one produced following faithfully the original methods of Dr. W. H. Schuessler, according to the British patent <u>GB</u>2527483.
